

PRESENTATION AND ADOPTION OF 2019 OPERATING BUDGET

COUNCIL PRESIDENT

In my annual report last year, I laid out 4 ways that we would implement our theme of "connections:" a focus on communications, quarterly "chat sessions," re-shaping our committees, and realizing the gifts of our Community Organizer. I am pleased to report the outcomes of these initiatives here:

- 1) We hired an experienced professional to oversee our Communications strategy. As Assistant Director of Communications, Esperanza Foft has brought us into the 21st century to help us "spread the Word" with consistent messaging and innovative approaches.
- 2) We held 4 Congregation Matters meetings (formerly "council chats") last year. Each was an opportunity for the council and administration to keep you informed about all of the "goings-on" around St. John's, and for you to ask questions and get answers.
- 3) We reviewed our committee memberships and structure, and made a few key changes in our revised bylaws (more on that during another part of the agenda)
- **4)** Rebekah Turnbaugh realized her gifts in so many areas, we decided to promote her to a full Director at St. John's. (see her report)



One of my priorities last year was to update our Constitution and bylaws. We formed a committee, chaired by Bob Huckfeldt, which worked diligently to align our constitution with the national ELCA model, and to update our bylaws to match our current practices. We will vote on those changes at this annual meeting.


Also in 2018, we began our "Raise the Roof" campaign to ensure that our building will be here for generations to come. If you haven't yet contributed to this worthy cause, I encourage you to do so!



Looking ahead to 2019, I am excited to see how our new council will implement the 2 main initiatives identified at our latest strategic planning session – to more comprehensively address issues facing our unhoused neighbors, and to begin a campus planning process that identifies how to use our property in a way that most effectively aligns with our mission. We have already identified chairpersons to lead these 2 new committees.

I am also excited by the prospect of calling our 3rd pastor this year. (This will be the 4th Call process that has occurred during my tenure!) I am thankful for the excellent work of our Call Committee. You can read the latest on the Call process in their report.

Although I am sad to leave the company of this amazing group of leaders, I leave with great optimism for our future. It has been a joy to serve St. John's in this capacity, and I am proud that we have established a strong foundation on which future leaders will continue to build. I also want to acknowledge the excellent work of our Executive Director, Linda Baldwin, for all of her leadership and support of Pr. Frank, me, and the council.



At his inauguration earlier this month, Gov. Newsom quoted an African proverb: "If you want to go fast, go alone. If you want to go far, go together." I look forward to seeing how far we will go together as we continue to live out our mission.

As I ponder the year just behind us (2018) and the year to come (2019), our current **Home** theme is the perfect way to describe our life together. Here at St. John's, we are living out our faith in a Full House!! In other words, St. John's is a lively and purposeful place where we all bring our greatest hopes and disappointments expecting God will meet us in powerful spiritual experiences that lead us to big commitments! Over and over again, we are met, welcomed, spiritually fed, challenged and comforted here. It is how we have a hope of living into our mission - to live God's Love in the world! When I think of us as a Full House, this is what I mean:

We will undoubtedly welcome our 3rd pastor to St. John's this year. The Call Committee is diligently at work – thank you to Call Chair Joel Kimmelshue, Catherine Zanzi, Ashley Ford, Jim Kuhl, Maryann Hanner, and Pastor Jon Haug, who with me are charged with and doing this important work. Our 3rd pastor also will serve as St. John's Director of Outreach, expanding our capacity to invite, love and serve those in spiritual need of a good welcome home!



A home needs a good roof, and because of the success of our Home Improvement -Raise the Roof Capital Campaign, our sanctuary building will have a new one and fully paid off by February, 2020. To date, our Home Improvement Capital Campaign has gathered over \$772,000 in pledges which, when supplemented with already existing funds, will cover the cost of the new copper roof, parking lot improvement, and plaster repairs. If continuing Capital Campaign pledges comes in, we hope to fund the courtyard expansion that impacts our parking lot renovation. We need room for our Full House! That is why we are working hard to preserve and improve our precious space.

Because we continue to grow in faith and participation and members and zeal, it is clear that the impact of our **Full House** continues to be felt through inspirational worship, vibrant faith and spiritual life formation for all ages, meaningful engagement in and with our Sacramento community, and service through acts of mercy for, and bold advocacy on behalf of, those marginalized in our society. Thank you to our **Full House** of active members, friends and leaders who undertake this work with full and open hearts, knowing they will be positively changed through love of God and love of neighbor.

I thank God for St. John's Welcome Statement that means we are not going to give up on, or demonize, any human being. In fact, we here at St. John's understand that as we become more diverse, we resemble more fully the Body of Christ active and at work in our world today. I thank God for our Luminaria program that brings into membership and full congregational life over 40 individuals and their families this and every year. Luminaria is our life blood – through our deep commitment to this intentional process of faith formation, we come to know and understand the many gifts of people that make up a Full House! Thanks be to God for that.

In the fall, we expect to welcome an intern from Pacific Lutheran Theological Seminary ("PLTS"). This is an opportunity not only for the intern studying to become a pastor, but also for us, becoming more directly linked with the training of the future leaders of our church.



Of special note here is St. John's longstanding relationship with PLTS. In the 1950's, former Senior Pastor Robert Romeis urged St. John's to financially support moving PLTS to Berkeley and later served as Chair of its Board of Directors. We continue to be a significant supporter of PLTS and serving as an Internship congregation for pastors-intraining to use a set-aside year to hone real life ministry skills is a wonderful expansion of this longstanding commitment to PLTS and the church.

We have grown our budget to meet the expansion of these ministry opportunities – pledges to our 2019 General Fund increasing by \$80,000. This is a really big deal for us as we invest again to become a three-pastor church, expanding our capacity in many ministries, including teaching the faith.

In all of this, it is a joy to serve as your pastor. I cannot think of anything else I would rather be doing than to be a part of the ministry of this **Full House** we know as St. John's.

Thank you and God bless you for your faithful witness of Christian love in these times in which we live!

Looking Forward to 2019 with Great Optimism (and a little Fika*)

Between February of 2018 and June of 2018, I took on the role of Acting Executive Director of Administration and Resources and became the permanent Executive Director on July 1, 2018. During that time, we successfully hired our Assistant Director for Communications, Assistant Director for Worship and Music, both Property and Maintenance Supervisors, Property Assistants and A/V Tech. During my short tenure here, I have made some thoughtful changes to practices that have resulted in better efficiencies and less staff frustration. My goal is to continue to work closely with all staff to ensure their success in their work here and to provide support along the way.

As you are all aware, 2018 brought more than one major property project. The improved fencing and gating of our parking lot was the first, with the completion of parking lot asphalt and drainage due to be complete this spring. And along came the re-roofing project. It has been quite the learning experience, working with the City of Sacramento, our architect, our contractor and our lender to bring this to fruition. Although we have had the inconvenience of not having access to our parking lot, and a few minor drips, I know we will all be very pleased ultimate result that we will all see soon, and the legacy it leaves to coming generations here at St. John's. I have worked closely with our Accountant, Kat, to understand where we were, where we are now, and where we are going fiscally.



We ensure and honor the specific requests of our members pledges and offerings, utilizing your contributions carefully to further the work of our many ministry areas.

Overall, I am very optimistic about 2019. Our staff has done an incredible job in 2018 in every area. We have built a staff that is collaborative, believe in our mission, and carry it out in the most professional, compassionate, and productive ways.

And it makes good business sense: firms have better teams and are more productive where Fika is institutionalized. Fika has now become part of our staff meetings and beyond, lingering after business discussions are finished - to simply be with one another.

With more than a full year under her belt, Rebekah Turnbaugh is now our Director of Community Organizing and has started to form deeper relationships with people and groups here as well as in the community.

2018

- In July, many members and friends of St. John's participated in the Sacramento Pride parade and festival, proclaiming that all are welcome here.
- On September 9, 2018, more than 100 members from St. John's Lutheran Church participated in the ELCA Day of Service. This year we were able to partner with community groups like Midtown Association, the Front Street Animal Shelter, the Land Park Volunteer Corps, the City of Sacramento, Saint John's Program for Real Change, and City Church.
- Held conversations around the killing of Stephon Clark within the congregation, leading to the formation of a Racial Justice group that will soon be offering opportunities for the larger congregation to be engaged in racial justice work.
- Strengthened the execution of our food and clothing pantry with dedicated volunteers, specific hours, and new volunteer coordinators.
- Held two "Soul to Soul" gatherings of members from both St. John's and City Church to start getting to know one another.
- Connected congregation members to ministries and other areas of service through the Time, Talents, & Passions survey responses.
- Incorporated commitments around service and justice into Stewardship pledge.
- More than 50 members volunteered to greet and welcome worshipers on Sundays and during Christmas Eve and Christmas Day while roof construction closed our parking lot.



2019

- Continue to deepen relationship with City Church.
- Participate in the creation of a Committee on Homelessness.
- Continue working with Racial Justice group and actions it might take in the congregation and community.
- Follow-up, as needed, on service and justice pledges to support members in living God's love throughout the community.
- Administer a 2019 Time, Talents, and Passions survey.



Social Ministry Team Work 2018

- This year, we established a food and toiletries pantry in the main church offices to provide for the immediate need of those experiencing homelessness.
- We reviewed the time and talent sheets and connected members who expressed an interest in social ministry opportunities.
- We began a series of videos about the various social ministries for presentation before services, beginning with The Pilgrimage and our Thanksgiving Community meal.
- We welcomed Mark and Judy Sektnan as Habitat for Humanity coordinators.
- We reached out to members interested in our Rwandan connections and hosted two events, including a conversation with Pastor Frank and Rhonda about their trip to Rwanda.
- We set up a series of warehouse-organizing sessions at St. John's Program for Real Change.
- We continued to support The Pilgrimage, which gathered twice monthly to provide dinner, breakfast and a night of shelter for people who are homeless or hungry. We sought to build relationships with guests of The Pilgrimage and similar programs to better inform our ministry planning.
- We continued to support efforts to welcome guests for four weeks of overnights through the Family Promise program.
- We hosted Easter and Thanksgiving community meals, using them as an opportunity to connect members with other volunteer opportunities in social ministry.
- We made plans for continuing the support and growth of our social ministries in 2019.
- And we gave thanks to God for all of the many loving people at St. John's and in our community who made all of this possible.



It's been a privilege to do this work. I am stepping away from leadership in this group, and I pray that God will bless the work of social ministry at St. John's with new leadership in 2019.

LIBRARY COMMITTEE CHAIR

This was a busy year at St. John's, full of classes and events. The significance of this to the library is that people do not linger further, and this is reflected in our circulation of 74 compared to 133 last year. But let's not forget the elephant in the room—the disruption of habits and access from over three months of work on our roof.

During 2018, we added 51 items at a cost of \$937 compared to the previous year with addition of 56 items and expenditure of \$379. The disparity is probably because the titles were purchased the year before but cataloged last year. Also this year we spent time weeding, removing dated material, a process that makes room for newer material. We continue use of the display case by the elevator. Danna Olson continues her volunteer work

We have had more in-house digital exposure to the congregation, helping to reveal the continuing stream of new material on religion, history, and social justice issues.

One part of our collection that is totally underused is books for children. This is where the library can be a real asset. Children change and grow and want to experience new things. What parent wants to spend money on something that will be used once and tossed or relegated to the closet or Goodwill? Borrow books to be read once and move on to the next title that looks interesting.



Many folks think everything is available online, on tablet, you name it. But, for comparison, if a person looks up what is in print, it becomes obvious that ephemeral sources provide ephemeral material like best sellers and not really things of substance like religious topics. Books continue to offer real information; and libraries offer the economical alternative by loaning a book which a person will read only one time.

Since accepting the position of Assistant Director, Communications in May 2018, I have been tasked to tell St. John's story in the best way possible. As I quickly came to realize in my new position, St. John's is so much more than a church.

It is a venue, a classroom, a safe place, and more importantly - an ever growing community. I am honored to play the role as narrator to St. John's story and to effectively share it with the congregation, new visitors and the city of Sacramento.

My assignment in 2018 was to analyze all sources of St. John's communications, and to make sure each were being utilized in the most beneficial way.

In 2018, we have:

- Increased our e-weekly database by 10% with database management and new-signups. In addition, our open rates have increased to 34.4% (industry average is 26.1%) and our click rate is 4% (industry average is 2.6%).
- Had 5,162 users visit the St. John's website with 22,394 views since June 2018. We also came to find out that our website visitors are accessing our site equally through their desktop and mobile devices. This new information has led to recent website designs that are more mobile-friendly, including a more direct access to Worship Times and Parking Information which may prove helpful to new visitors. In late December alone (December 20 -December 31), we had 276 visitors click on this recently added link.
- Increased our Facebook likes by 13.5%; Instagram followers by 44% since May 2018 due to consistent content creation.



In 2019, my goals are:

- To assemble a team of volunteer videographers and photographers to capture all of St. John's events for historical and promotional purposes.
- To add a St. John's podcast as a communications outlet that will provide the weekly sermons and original content.
- To identify our community partners, and fully support them through our communications outlets.
- To increase congregation involvement by successfully communicating all the wonderful events we host here at St. John's.


AUDIT COMMITTEE CHAIR

The Audit Committee was appointed in 2017 to conduct an evaluation of the financial records and the internal controls of St. John's for the purposes of assessing the reasonableness of the church's financial statements and recommending improvements to its internal control processes. Members of the committee included Lance Lewis (Chair), Karin Johnson and Kurt Barneson. We evaluated the financial statements of St. John's which comprise the statements of financial position as of December 31, 2017 and 2016, and the related statements of activities and cash flows for the years then ended, and the related notes to the financial statements. To guide our work, the Audit Committee followed agreed-upon procedures and those recommended by the Evangelical Lutheran Church in America (ELCA). Because St. John's prepares its financial statements on a cash basis and not accrual. we did not render an opinion. The Audit Committee worked with staff and the Church Council to identify accounting best practices and opportunities for strengthening the church's internal controls which are in the process of being implemented. The Audit Committee will reconvene periodically to monitor and evaluate the financial accounting systems as requested by the Church Council.



2018 Financial Highlights

We have a dynamic, responsive and generous congregation who have continuously raised to new opportunities and challenges. Our needs and programs continue to grow, and the congregation's commitment and generosity has grown with those needs. We are truly living up to our commitment of "Living God's Love in the World". Fiscally, the church is on firm ground. Cash increased slightly over last year and a small cash surplus for unforeseen occurrences exists. We have a very responsive, efficient and friendly administrative staff, led by Linda Baldwin.

An audit committee led by Lance Lewis was formed and a financial audit for 2017 and 2018 was performed. The last audit occurred in 2004 or 2005. Several procedural process corrections were recommended, and staff agreed with and responded to the recommendations and began making changes to conform. A follow-up audit for 2019 is in the planning stages.

This year is the final year of my commitment as Treasurer. It has been an honor serving these past five years, seeing and participating in the period of growth and positive changes, along with some occasional challenges.



General Fund

Offerings for the year totaled \$1,311,346 and budget was \$1,285,000 which is 102% of budget. Total income for 2018 was \$1,635,109 while operating expense was \$1,609,555, providing an operating surplus of \$25,554. Interest and dividend income contributed \$7,150 for a total net income of \$32,704.

Benevolence contributions for the year were 13.1% of operating expenses. Cash benevolence contributions for 2018 was \$177,901 and the fair market value of rent provided to St John's Program for Real Change for Plates2go is estimated to be \$33,000.

Committed and Restricted Funds

Other contributions in 2018 include unrestricted bequeaths and restricted contributions, totaling \$695,880. The Council has pledged to safe-guard and reserve rents received from 1st English and unrestricted bequests with the goal of building a base to establish an endowment fund. Rents received from City Church were \$30,000 and one-time unrestricted bequeaths were \$349,557. The remainder, \$316,323 represents contributions to restricted funds, including \$243,131 for our new roof.

Raise the Roof

Drip after drip and patch after patch finally morphed into the reality a new roof was necessary. Because our beautiful building is 100 years old, the city's historical building section required historic authenticity for the replacement roof. A congregational meeting authorized a mortgage to finance this project. As of December 31, contributions received totaled \$243,131. Because the response has been so great, we have been able to postpone drawing funds on the loan until mid to late January. Fantastic! Executive Director of Administration, Linda Baldwin has led the process, from investigation, discovery, negotiation and coordination with architect, contractors and lending instruction, and deserves special recognition for her efforts and results. Thank you, Linda.

2019 Budget

Income projections for 2019 are based on historical calculations of pledges received to date. Total projected income for 2019 is \$1,778,076 which is lower than 2018 projection. This variance is due to a large known bequeath received in 2018 and not anticipated for 2019.

Budgeted expense was projected on needs of each ministry area, determined by consultation with directors and includes provisions to fund our third pastor position as well as maintain full staffing. Interest expense for the loan on the roof is anticipated to be \$28,875 for 2019. Total budgeted expense for the year is expected to be \$1,768,076.

As roof has outlived its lifespan, the sanctuary has sustained water damage and our insurer will no longer provide coverage if we continue to neglect our due diligence in property maintenance, we are proposing to replace the roofs. Architect, Kevin Pressey, presented the work done with the city for approval of acceptable roofing material to meet the requirements of a historical building. The city has approved using a metal roof as was originally on the sanctuary when it was built. Bids were received from three contractors with expertise in working with historic buildings and excellent workmanship. The architect evaluated the bids and determine that they were all equally qualified Contractor John Ravetti of Waterproofing Associates, Inc. submitted the lowest bid and the recommendation is to award the job to this contractor.

Questions were received from the congregation regarding the execution of the project, the safety of the building materials and the cost of the project.

Lance Lewis moved that the congregation approve acceptance of the bid proposed by Waterproofing Associates to remove and replace all roofs on the church buildings located at 1701 L Street for a total cost of \$761,400. Seconded by Ann Boynton and passed unanimously.

5. Cost and Financing

The church has been pre-approved for a construction loan by Mission Investment Fund and we will hold a capital campaign to repay the loan. The Council is recommending also including the completion of the parking lot drainage and paving and repair of plaster damage in the loan amount.


