### FROM THE COUNCIL

My first meeting on the St. John's Church Council was in January 2010. I'll never forget it. We had an opportunity to purchase a property adjacent to the church, but we were struggling to pay off a major debt from the renovation of our church sanctuary. It was a tough vote, but the council recommended the purchase to the congregation. After two hours of discussion about the challenges and opportunities, the annual congregational meeting voted overwhelmingly: Yes!

That was a moving demonstration for me about the deep sense of mission at St John's. Since then, I have often seen this congregation choose the bold path over a modest one; make a generous commitment instead of a polite gesture or act, together, as a community inspired by the amazing opportunity to live God's love in the world. You have inspired me. Serving on the council has been one of the most meaningful opportunities of my life.

This month, I leave the council after serving for six years. In addition to the property purchase and the debt payments, we have called three pastors, recruited talented staff, spread our word to new communities in midtown and shared our assistance to broader populations in need of food and housing.

It was a lot of work. And it was only possible because of your impressive generosity and commitment. Our Living Stones campaign -- to pay down more than \$2 million of debt from our sanctuary renovation by 2017 -seemed extraordinarily ambitious. It's truly humbling to say today that we will reach that goal this year on schedule. To me, it's a vivid demonstration about the value of this church to so many of our lives and the solid foundation that will assure St John's moves forward.

The good news is that I feel like I'm leaving just as the best part is beginning. This year is a remarkable celebration for St John's. We will end our debt, mark the 500th anniversary of the Reformation and celebrate our sesquicentennial with a generational gift that will add four new stained glass windows to our beautiful and historic collection.

I take it as God's gift that my last vote on the council will be to sell a property for St John's. Thanks to the congregation at the former First English Lutheran Church, we have been blessed with the opportunity to pass this property in Oak Park to City Church, a new and growing worship community. Instead of a possible housing development, I hope we will help spread the word of God in Oak Park and nurture a new relationship with a young and growing congregation. I look forward to our final decision about this property at our annual congregational meeting in January.

Today, that property we purchased in 2010 is worth far more than we paid. It was a pawn shop when we bought it, and today it is a restaurant that trains the homeless clients from the St John's Program for Real Change. Even more important, it reflects a church that truly lives God's love in the world.

### From the Senior

Confession time (probably not a great way for a Pastor to start a congregational annual report, but now I have your attention)! Five years ago, I did not know what "Sesquicentennial" meant. Honestly, I didn't even know it was a word! But boy does it ever occupy my thoughts and prayers now!

The calendar turning 2017 means our Sesquicentennial year has arrived. St. John's has reached its 150th birthday, an important year in our history, and an important year in our lives. Unlike many institutions our age, we are not limping into this big anniversary. We thrived in this last decade as many other Christian congregations in our country languished. We experienced sustained growth, property restoration and acquisition, a thriving discipleship/new member process (Luminaria), and increased personal and financial investment in the life of our congregation. Over the last four years we've seen a massive reduction in debt. Our mission makes sense to us, "To Live God's Love in the World," and it does not appear that the world's need for love (in very specific action on our part) is decreasing any time soon.

We have a lot of celebrating to do in 2017. A letter to members and friends outlining all our Sesquicentennial events was mailed a few months back. There are many highlights to come, but at the top of the list for me are two things: a visit by the Presiding Bishop of the ELCA, Elizabeth Eaton, from August 5-6, and the celebration on Christ the King Sunday, November 26, which is the Sunday after Thanksgiving. On Christ the King Sunday we will observe our 150<sup>th</sup> anniversary and, hopefully, pay off the sanctuary restoration debt and "burn the mortgage" assuming we succeed in fulfilling our Living Stones pledges.

2016 was an important year of strategic planning and the stabilization of our staffing and programs. Having previously achieved our goal to call three pastors, we now needed staff for administrative excellence. In November, through an almost yearlong call process that converted into a lay search, we brought St. John's member Diane White on board as our new Director of Resources & Administration. With a background in college administration, similar to Ryan Eikenbary who served as our Interim Director of Resources & Administration, Diane has hit the ground running with many gifts in management, resource development and strategic planning. As an extra benefit, Diane is a calm, almost serene, force to complement my excitable style. I think we are going to be a great team to develop and drive St. John's ambitious mission into and beyond our Sesquicentennial year.

Diane's competency with strategic planning will complement the work of

### the 2016 Council Retreat, which sought to give some form to St. John's ambitions through the rest of this decade. A planning culture is starting to develop here that will serve us well in the years/decades to come. Thank you to St. John's Member and Community Organizer Ron Dwyer-Voss who gave time to lead the Council, the strategic planning-charged Wonderers' Task Force, and the St. John's Directors/Pastors in this important work of strategic planning.

We continue in the midst of a significant stewardship work - the shepherding of the former First English Lutheran Church campus in Oak Park - to its next ministry use. As of the writing this report, although we are close to a making a dispositive decision, no reportable resolution has solidified. However, I anticipate that action very well may be needed by the Congregation to act on the Council's decision of disposition. The guiding principle of the Council's discernment has been to keep vibrant Christian ministry at this location in Oak Park, consistent with St. John's overall mission. As you will recall, the congregation last January agreed to receive this real property by gift distribution, and the Council continues to work hard to discern and implement appropriate steps to take this property, and/or the proceeds therefrom, to its next ministry use.

Finally, I wish to announce to the congregation what has been known in leadership for some months now. I will be taking a much delayed sabbatical after Easter from April 17-July 17, 2017. After submitting a detailed and ambitious grant proposal to the Lilly Endowment for my sabbatical through a nationally competitive program Lilly runs for clergy renewal, St. John's has received a grant that substantially underwrites my sabbatical! I am excited to set aside time for renewal and believe it will be good for my leadership at St. John's in the years to come. In addition to a two week family vacation in Scandinavia, I will research and explore urban congregations engaged in interesting downtown ministry in the American northeast and northwest. This is in addition to retreats and adventures at Sea Ranch, Holden Village, Florida and Sweden. Thank you for making this sabbatical available to me through St. John's excellent employee policies.

A lot is exciting and new for us this year, but some things never change: an ambitious budget to meet even more ambitious ministry plans. Our desire is to find effective and impactful ways here at home and around the world to experience God's love by coming to the respectful assistance of those in need. Our God is calling us to follow, and I hope that like me, you are all in to do this labor of love together.

Every time we gather we are committed to growing as disciples of Jesus. Whether in worship, Sunday school, craft night, community meals, outreach or simply meeting to pray for one another, we are reminded that discipleship does not happen on our own. This community of faith is a place that nurtures our spirits, challenges our hearts and emboldens us in the power of the Holy Spirit to go into the world as witnesses to the love of God in Christ Jesus.

Over the past year we have gathered in many ways. Adult education on Sunday mornings continues to be a lively gathering, bravely delving into scripture and theological topics. This past year we looked at Romans, Hosea, Amos and a bold group of 60 readers went cover to cover in the Bible in 90 Days! We also looked at the Lord's prayer and Apostles' Creed as well as Luther, Calvin and American evangelicalism. Good learning for all of us!

Our giving at Lent and Advent reflected an outward focus as we supported the Habitat for Humanity Build for Unity project as well as the work of ELCA world hunger. Thank you for your prayerful generosity and involvement in these projects. As I write this, our food closet is filling up to assist our neighbors in need, and the walls are being raised on two homes on Neal Road that will house families in safety. What could be a better way to end the year?

Outreach saw many of our members handing out safety lights and engaging in conversation at the Pride parade and festival in June. Many hands cooked and served nearly 600 hundred meals at Easter and Thanksgiving, not to mention the suppers and breakfasts that feed our Pilgrimage guests twice a month. God's Work: Our Hands Sunday in September brought us together as we baked and delivered goodies to our community first responders. Trash pickups in midtown, planting, helping one another with moves and chores, giving rides, volunteering with publications, ushers, greeters - these are just a few of the ways you all reach out to the community around us to invite others into the love we share here at St. John's in Jesus. Thank you for a great year and let's be bold to share in the new one. It's a blessing to gather with you!


